BYLAW No. 4467

A Bylaw to Amend Area E Critical Location Streetlighting Service Establishment Bylaw No. 2141

WHEREAS the Board of the Cowichan Valley Regional District established the *Cowichan Station/Sahtlam/Glenora Critical Location Streetlighting Service Establishment* under the provisions of Bylaw No. 2141, cited as "CVRD Bylaw No. 2141 – Electoral Area E – Cowichan Station/Sahtlam/Glenora Critical Location Streetlighting Service Establishment Bylaw, 2000", as amended;

AND WHEREAS the Regional District wishes to amend Bylaw No. 2141 by increasing the maximum annual requisition limit from \$7,000 to the greater of \$8,750, or an amount that equals the amount raised by applying a property value tax rate of \$0.00562 per \$1,000 to the net taxable value of land and improvements within the service area;

AND WHEREAS the Director of Electoral Area E – Cowichan Station/Sahtlam/Glenora has consented, in writing, to the adoption of this bylaw;

NOW THEREFORE the Board of Directors of the Cowichan Valley Regional District, in open meeting assembled, enacts as follows:

1. CITATION

This bylaw may be cited as "**CVRD Bylaw No. 4467 – Cowichan Station/Sahtlam/Glenora Critical Location Streetlighting Service Amendment (Requisition Limit Increase) Bylaw, 2023**".

2. AMENDMENTS

That CVRD Bylaw No. 2141 be amended as follows:

1. By deleting in the first WHEREAS clause in the preamble "Section 796 (1) of".
2. By deleting in the third WHEREAS clause "Seven Thousand (\$7,000)" and replacing it with "Eight Thousand, Seven Hundred Fifty (\$8,750)".
3. By deleting in the fourth WHEREAS clause in the preamble "Section 172.4 of".
4. By deleting in Section 2 "Section 769 (1) of".
5. That Section 5 be deleted in its entirety and replaced with the following:

"METHOD OF COST RECOVERY"

5. The annual cost of providing the service will be recovered by one or more of the

following:

- a) property value taxes imposed in accordance with the *Local Government Act*;
- b) parcel taxes imposed in accordance with the *Local Government Act*;
- c) fees and charges imposed in accordance with the *Local Government Act*;
- d) revenues raised by other means authorized under the *Local Government Act* or another *Act*; or
- e) revenues received by way of agreement, enterprise, gift, grant or otherwise."

6. That a Section 6 be added with the following:

"MAXIMUM REQUISITION

6. The maximum amount that may be requisitioned annually for the cost of this service is the greater of:

- a) Eight Thousand, Seven Hundred Fifty Dollars (\$8,750); or
- b) a property value tax rate of \$0.00562 per \$1,000 applied to the net taxable value of land and improvements within the service area."
