BYLAW No. 4527

A Bylaw to Amend Bylaw No. 1958 – Garbage and/or Recyclable Materials Collection Bylaw, 1999

WHEREAS the Board of the Cowichan Valley Regional District established a service for the collection of garbage and/or recyclable materials pursuant to Bylaw No. 1958, cited as “*CVRD Bylaw No. 1958 - Cowichan Valley Regional District Garbage and/or Recyclable Materials Collection Bylaw 1999*” as amended;

AND WHEREAS the Board of the Cowichan Valley Regional District wishes to revise the rates in Schedule A – Recycling and Garbage Collection Rates of the bylaw.

NOW THEREFORE the Board of Directors of the Cowichan Valley Regional District, in an open meeting assembled, enacts as follows:

1. CITATION

This Bylaw may be cited for all purposes as "**CVRD Bylaw No. 4527 – Recycling and Garbage Collection Rates Amendment Bylaw, 2024**".

2. AMENDMENT

That CVRD Bylaw No. 1958 be amended by:

- a) deleting the table in Schedule A under bullet point 1 and replacing it with the following:

- b) adding the following in Schedule A, as bullet point 4:

Garbage Tote Upgrade Fees:

- i. Standard Garbage Sized Tote (140L) – see the basic rate under bullet 1 schedule A
- ii. Medium Garbage Sized Tote (240L) – an additional annual fee of \$26
- iii. Large Garbage Sized Tote (360L) – an additional annual fee of \$57
