## **PURPOSE/INTRODUCTION**

The purpose of this report is to request Board consideration of bylaw amendments to enhance enforcement within Development Permit Areas.

## **RECOMMENDED RESOLUTION**

That it be recommended to the Board:

1. That CVRD Bylaw No. 4587 – Development Application Procedures Amendment Bylaw, 2024, be considered for three readings and adoption.
2. That CVRD Bylaw No. 4588 – Ticket Information Authorization Amendment Bylaw, 2024, be considered for three readings and adoption.

## **BACKGROUND**

The purpose of [CVRD Bylaw No. 3209 – Ticket Information Authorization Bylaw, 2008](#), is to authorize the use of Municipal Ticket Information (tickets) for the enforcement of certain bylaws, to designate persons as Bylaw Enforcement Officers, to authorize the use of certain words or expressions, to designate specific bylaw offences and to set fine amounts for bylaw offences.

[CVRD Bylaw No. 4483 – Development Application Procedures Bylaw, 2023](#), establishes procedures for development of land, the application process and associated permits and fees.

## **ANALYSIS**

The amendment to Bylaw No. 3209 – will enable ticketing provisions specific to offenses associated with unauthorized works in Development Permit Areas (DPAs) such as altering land and undertaking construction activities without first obtaining a development permit authorizing such works. Additionally, persons who have obtained Development Permits (DP) authorizing works within a DPA may be ticketed for failing to comply with the terms and conditions of the permit by not adhering to the specific development conditions set out within the permit.

Corresponding amendments to CVRD Bylaw No. 4483 – Development Application Procedures Bylaw, 2023, are needed for consistency with the Ticketing Bylaw.


