BYLAW No. 4613

A Bylaw to Amend Cobble Hill Village Sewer System Service Establishment Bylaw No. 4205

WHEREAS the Board of the Cowichan Valley Regional District established the *Cobble Hill Village Sewer System Service Area* under the provisions of Bylaw No. 4205, cited as "CVRD Bylaw No. 4205 – Cobble Hill Village Sewer System Service Establishment Bylaw, 2018", as amended;

AND WHEREAS the Board of the Cowichan Valley Regional District wishes to extend the boundaries of the service area to include the following Eight (8) properties:

- PID: 027-984-222 – Strata Lot 5, Section 13, Range 6, Shawnigan District, Strata Plan VIS6835 together with an interest in the common property in proportion to the unit entitlement of the strata lot as shown on Form V
- PID: 027-984-206 – Strata Lot 3, Section 13, Range 6, Shawnigan District, Strata Plan VIS6835 together with an interest in the common property in proportion to the unit entitlement of the strata lot as shown on Form V
- PID: 027-984-192 – Strata Lot 2, Section 13, Range 6, Shawnigan District, Strata Plan VIS6835 together with an interest in the common property in proportion to the unit entitlement of the strata lot as shown on Form V
- PID: 027-984-184 – Strata Lot 1, Section 13, Range 6, Shawnigan District, Strata Plan VIS6835 together with an interest in the common property in proportion to the unit entitlement of the strata lot as shown on Form V
- PID: 003-725-031 – Lot 1, Section 12, Range 6, Shawnigan District, Plan 19424 except part in Plan VIP72609
- PID: 027-984-214 – Strata Lot 4, Section 13, Range 6, Shawnigan District, Strata Plan VIS6835 together with an interest in the common property in proportion to the unit entitlement of the strata lot as shown on Form V
- PID: 006-909-451 – Lot 6, Block 15, Section 12, Range 6, Shawnigan District, Plan 1809
- PID: 001-510-517 – Lot 4, Section 13, Range 6, Shawnigan District, Plan VIP1986

AND WHEREAS the owners of the above noted properties have petitioned the Regional District to have their property included in the service area;

AND WHEREAS the Director of Electoral Area C – Cobble Hill, has consented, in writing, to the adoption of this bylaw;

NOW THEREFORE the Board of the Cowichan Valley Regional District, in open meeting assembled, enacts as follows:

1. **CITATION**

This bylaw may be cited for all purposes as "**CVRD Bylaw No. 4613 – Cobble Hill Village Sewer System Service Area Amendment (Boundary Extension) Bylaw, 2024**".

2. **AMENDMENT**

That Bylaw No. 4205 be amended by deleting the existing Schedule A and replacing it with the Schedule A attached to this bylaw.
