



## COWICHAN VALLEY REGIONAL DISTRICT

### BYLAW No. 4466

#### A Bylaw to Amend Area I Critical Location Streetlighting Service Establishment Bylaw No. 2144

---

**WHEREAS** the Board of the Cowichan Valley Regional District established the *Youbou/Meade Creek Critical Location Streetlighting Service Establishment* under the provisions of Bylaw No. 2144, cited as "CVRD Bylaw No. 2144 – Electoral Area I – Youbou/Meade Creek Critical Location Streetlighting Service Establishment Bylaw, 2000", as amended;

**AND WHEREAS** the Regional District wishes to amend Bylaw No. 2144 by increasing the maximum annual requisition limit from \$1,555 to the greater of \$6,500, or an amount that equals the amount raised by applying a property value tax rate of \$0.00383 per \$1,000 to the net taxable value of land and improvements within the service area;

**AND WHEREAS** the Director of Electoral Area I – Youbou/Meade Creek has consented, in writing, to the adoption of this bylaw;

**NOW THEREFORE** the Board of Directors of the Cowichan Valley Regional District, in open meeting assembled, enacts as follows:

1. **CITATION**

This bylaw may be cited as "**CVRD Bylaw No. 4466 – Youbou/Meade Creek Critical Location Streetlighting Service Amendment (Requisition Limit Increase) Bylaw, 2023**".

2. **AMENDMENTS**

That CVRD Bylaw No. 2144 be amended as follows:

1. By deleting in the first WHEREAS clause in the preamble "Section 796 (1) of".
2. By deleting in the third WHEREAS clause "One Thousand (\$1,555)", and replacing it with "Six Thousand, Five Hundred (\$6,500)".
3. By deleting in the fourth WHEREAS clause in the preamble "Section 172.4 of".
4. By deleting in Section 2 "Section 769 (1) of".
5. That Section 5 be deleted in its entirety and replaced with the following:

**"METHOD OF COST RECOVERY"**

5. The annual cost of providing the service will be recovered by one or more of the following:

- a) property value taxes imposed in accordance with the *Local Government Act*;
- b) parcel taxes imposed in accordance with the *Local Government Act*;
- c) fees and charges imposed in accordance with the *Local Government Act*;
- d) revenues raised by other means authorized under the *Local Government Act* or another *Act*; or
- e) revenues received by way of agreement, enterprise, gift, grant or otherwise."

6. That a Section 6 be added with the following:

**"MAXIMUM REQUISITION**

6. The maximum amount that may be requisitioned annually for the cost of this service is the greater of:

- a) Six Thousand, Five Hundred Dollars (\$6,500); or
- b) a property value tax rate of \$0.00383 per \$1,000 applied to the net taxable value of land and improvements within the service area."
