



## COWICHAN VALLEY REGIONAL DISTRICT

### BYLAW No. 4516

#### A Bylaw to Amend CVRD Bylaw No. 3707 to Extend the Boundaries of the Burnum Water System Service Area

---

**WHEREAS** the Board of the Cowichan Valley Regional District established a water service system within a portion of Electoral Area B – Shawnigan Lake, known as the *Burnum Water System Service Area* under the provisions of Bylaw No. 3707, cited as "CVRD Bylaw No. 3707 – Burnum Water System Service Establishment Bylaw, 2013", as amended;

**AND WHEREAS** the Board of the Cowichan Valley Regional District wishes to extend the boundaries of the service area to include the following property:

- PID: 030-265-801, Lot A, Plan EPP58579, Section 7, Range 4, Shawnigan Land District

**AND WHEREAS** the owner of the above noted property has petitioned the Regional District to have the property included in the service area;

**AND WHEREAS** the Director of Electoral Area B – Shawnigan Lake has consented, in writing, to the adoption of this bylaw;

**NOW THEREFORE** the Board of the Cowichan Valley Regional District, in open meeting assembled, enacts as follows:

#### 1. CITATION

This bylaw may be cited for all purposes as "**CVRD Bylaw No. 4516 – Burnum Water System Service Amendment (Boundary Extension) Bylaw, 2023**".

#### 2. AMENDMENT

That CVRD Bylaw No. 3707 be amended as follows:

1. By deleting in the first WHEREAS clause in the preamble "Sections 796(1) and 800(1) of".
2. By deleting in the third WHEREAS clause in the preamble "Section 801.4 of".
3. By deleting in the fourth WHEREAS clause in the preamble "Section 797.4 of".

4. That Section 5. be deleted in its entirety and replaced with the following:

**"5. METHOD OF COST RECOVERY**

The annual cost of providing the service will be recovered by one or more of the following:

- a) property value taxes imposed in accordance with the *Local Government Act*;
- b) parcel taxes imposed in accordance with the *Local Government Act*;
- c) fees and charges imposed in accordance with the *Local Government Act*;
- d) revenues raised by other means authorized under the *Local Government Act* or another *Act*;
- e) or revenues received by way of agreement, enterprise, gift, grant or otherwise."

5. That Bylaw No. 3707 be amended by deleting the existing Schedule A and replacing it with the Schedule A attached to this bylaw.

READ A SECOND TIME this 13<sup>th</sup> day of September, 2023.

READ A THIRD TIME this 13<sup>th</sup> day of September, 2023.
