Uses and Zones Requiring a Buffer

For the illustrative maps depicting the retail sales of cannabis, a buffer of 300 m was created around parcels with the following uses or zones:

- Public and independent schools
- Park zones
- Institutional zones
- Water zones
- Playgrounds within parks that are not in Park zones
- Licensed child care facilities
- Sports courts and fields
- Community halls and recreation centres
- Other cannabis retail stores

Note that unlicensed child care facilities were not included in the maps.
