BYLAW No. 4288

A Bylaw to Amend Ticket Information Authorization Bylaw No. 3209

WHEREAS in accordance with *Community Charter* Section 264, the Regional District is authorized to use the Municipal Ticket Information System for: the enforcement of certain bylaws; to designate persons as bylaw enforcement officers; to authorize the use of certain words or expression to designate certain bylaw offences; and to set certain fine amounts pursuant to "CVRD Bylaw No. 3209 – Ticket Information Authorization Bylaw, 2008", as amended;

AND WHEREAS the Regional District deems it desirable and expedient to update the schedule of offences to implement a fine in relation to the placement of garbage and recycling totes at curbside prior to 5 a.m. on the day of collection pursuant to "CVRD Bylaw No. 1958 - Cowichan Valley Regional District Garbage and/or Recyclable Materials Collection Bylaw, 1999", as amended;

NOW THEREFORE the Board of the Cowichan Valley Regional District, in open meeting assembled, enacts as follows:

1. **CITATION**

This bylaw may be cited for all purposes as "**CVRD Bylaw No. 4288 – Ticket Information Authorization Amendment (Schedule 20) Bylaw, 2019**".

2. **AMENDMENT**

That Schedule 20 to CVRD Bylaw No. 3209 – Municipal Ticket Information Authorization Bylaw, 2008, be deleted and replaced with Schedule 20 attached to this bylaw.
