BYLAW No. 4352

A Bylaw to Amend the Boundaries of the Malahat Fire Protection Service Area

WHEREAS the Board of the Cowichan Valley Regional District established the *Malahat Fire Protection Service Area* under the provisions of Bylaw No. 2414, cited as CVRD Bylaw No. 2414 – Malahat Fire Protection Service Establishment Bylaw, 2003", as amended;

AND WHEREAS the Board of the Cowichan Valley Regional District wishes to extend the boundaries of the service area to include the following seven properties:

- PID: 029-942-004, Lot 6, Block 361, Malahat District, Plan EPP60055;
- PID: 001-106-686, Lot 1, District Lot 132, Malahat District, Plan 17128;
- PID: 027-514-366, Lot 4, District Lot 50, Malahat District, Plan VIP85007;
- PID: 029-735-921, Lot A, Blocks 156 And 201, Malahat District, Plan EPP55355;
- PID: 029-941-962, Lot 2, Block 361, Malahat District, Plan EPP60055;
- PID: 027-675-149, Strata Lot 1, Block 361, Malahat District, Strata Plan EPS21 Together With An Interest In The Common Property in Proportion To The Unit Entitlement of the Strata Lot As Shown On Form V; and
- PID: 027-675-246, Strata Lot 11, Block 361, Malahat District, Strata Plan EPS21 Together With An Interest In The Common Property in Proportion To The Unit Entitlement of the Strata Lot As Shown On Form V:

AND WHEREAS the owners of the above noted properties have petitioned the Regional District to have their property included in the service area;

AND WHEREAS the Directors for Electoral Area A – Mill Bay/Malahat and Electoral Area B – Shawnigan Lake have consented, in writing, to the adoption of this bylaw;

NOW THEREFORE the Board of the Cowichan Valley Regional District, in open meeting assembled, enacts as follows:

1. CITATION

This bylaw may be cited for all purposes as "CVRD Bylaw No. 4352 – Malahat Fire Protection Service Amendment Bylaw, 2020".

2. AMENDMENT

That CVRD Bylaw No. 2414 be amended by deleting the existing Schedule A and replacing it with the Schedule A attached to this bylaw.
