### **PURPOSE/INTRODUCTION**

The purpose of this report is to provide an overview of the 2020-2024 Five Year Financial Plan Amendment Bylaw No. 4347. The Bylaw is included in the Bylaw section later on the Board Meeting agenda for consideration of three readings and adoption.

#### **BACKGROUND**

The Cowichan Valley Regional District (CVRD) adopted its Five Year Financial Plan bylaw on December 11, 2019 and amended it on March 11, 2020 to include changes approved by the Board up to that date.

## **A**NALYSIS

The budgets of 15 functions have been amended between March and October 2020. All amendments were reviewed and subsequently approved by the Board.

#### FINANCIAL CONSIDERATIONS

The amendments result in a total budget increase of \$777,667 funded primarily through an increase in transfer from reserve and an increase in short term debt. There is no impact to requisition as a result of these amendments.

## **COMMUNICATION CONSIDERATIONS**

The CVRD website has been updated with new budget schedules as the amendments were approved by the Board.
